NO AGM-1/526/SMAM/2021-22: This is to notify to all the interested farmers, rural entrepreneurs and farmer group that under the scheme of Sub Mission on Agricultural Mechanization (SMAM). Department of Agriculture, Manipur is to provide Subsidy Assistance on purchase of farm machinery and equipment as well as for establishment of farm machinery bank for custom hiring for the year 2021-2 (2nd instt) as per prescribed pattern of assistance both for the fund of Central Share and Stare Share. Prescribed application format, pattern of assistance, list of equipment and list of approved Dealers can be had from the concerned District Agriculture Officer's Office. Duly filled up application in hard copy has to be submitted to the Office of the DAO concerned within stipulated time. Further farm equipment/machinery can be procured only from the following agencies who have on boarded in the Central DBT portal.

3. **Scheme of Group Farmers:** For Group Scheme (Custom hiring center, village based mechanization, etc.) the applicant group has to submit DPR along with the application form. The proposals are to be submitted through DAO concerned for recommendation for District Level Executive Committee (DLEC).
