Approval dated 17.08.2022, it is hereby notified that a State level Combined Entrance Test shall be conducted for the Selection of State Nominees for undergoing admission to various degree courses i.e, B.Sc.(Agri), B.Sc (Community Science), B.Sc (Food Nutrition & Dietetics) B.Tech.(Agri. Engg) and B.Tech.(Food Tech.) under Central Agricultural University , Imphal for the academic session 2022-23.

2. All the intending candidates of the State Domicile are hereby informed to log in to the Department of Agriculture website (www.agrimanipur.gov.in) and click on the pop-up menu to download Application Form / Admit Card & Instruction etc., and submit duly filled in Application & Admit Card form within the stipulated time. The download-link will be operational from 10:00 AM of 23.08.2022 till 04:00 PM of 30.08.2022. Candidates are informed to submit the hard copy of the form along with the relevant documents to the Training Officer, Directorate of Agriculture, Sanjenthong. Examination Fee/ processing charges will be Rs. 1000 for General/ OBC Candidates, Rs. 800 for ST/SC Candidates and Rs. 500 for PWD respectively per candidate.

3. For undergoing the above courses, candidates must scored 50% marks in aggregate of PCB/PCM/PCMB/Inter-Agri. for General & OBC categories and 40% marks for SC/ST/PwD categories in 10+2 / Inter-Agri.

4. Only female candidates can apply for the courses of B. Sc (Community Science) and B.Sc. (Food Nutrition & Dietetics) .

5. Scheme of Examination/test for selection of State nominees for various degree/courses can be seen in the Department website mentioned in para 2 above.

6. The date and venue of the Entrance Test shall be indicated in the Admit Card.
